Participation Guidelines

All in-person programs are currently structured to adhere to the guidelines provided by the Illinois Department of Commerce & Economic Opportunity (DCEO) for Phase 4 of the Restore Illinois plan. We kindly ask that you support a safe, phased reopening of our facilities by adhering to the following general guidelines set forth for all programs to help protect the well-being of our community.

Participants are asked to:

- Maintain social distancing of at least 6 feet between non-household individuals.
- Wear a face covering over your nose and mouth while inside facilities and when social distancing cannot be maintained. (Exceptions can be made for people with medical conditions or disabilities that prevent them from wearing a face covering.)
- Face coverings may not be required while exercising and swimming if a distance of 6+ feet is maintained.
- Wash your hands vigorously and frequently.
- Use hand sanitizer if hand washing is unavailable.
- Avoid touching your face.
- Cover your cough/sneeze.
- Bring your own source of water.

We ask that you do not participate in in-person classes or visit our facilities if you:

- Have been in contact with anyone who has tested positive for COVID-19 in the past 14 days.
- Are experiencing any symptoms of COVID-19, such as fever, cough, fatigue or shortness of breath.

Cleaning Protocols

The City of Elgin has established intensified cleaning protocols for each facility which includes:

- Cleaning and disinfecting of premises conducted in compliance with CDC protocols. * Detailed plan for facilities and each specific program.
- Frequent cleaning and disinfecting of common areas and surfaces that are touched by multiple people.
- Following CDC guidelines for cleaning and disinfecting for Community Facilities is a confirmed COVID-19 case is reported.
